 - If we are called for mutual aid, we will be responding to cover their district. We will not be called
 to respond to the current emergency they are operating at. The reason they are calling us is so
 as not to strip their area on a large scale event.
 - Only Engine 3 will respond. We will be purchasing more hard suction and a porta pump for Engine 3.
 - Response should include EMS and interior personnel, keeping in consideration that we also don't strip our area of EMS/Interior personnel.

- Engine 3 is to respond on a cold response only no lights or sirens.
- o Our mutual aid arrangement falls under the Erie County Mutual Aid Program we are a part of.
- A more formal plan and paperwork will be finalized between TLFD and South Wales in the near future.
